Terms and Conditions of Wholesale Sales



Plants available for wholesale purchase

As for 2017 perennial flowers, shrubs and trees are available for re-sellers purchase. Small amounts of annual plants might be available upon individual agreement.

To Open an Account

You must be established in the trade with a business location able to receive shipments.

Nursery License Requirement

All customers must possess a valid State Nursery Dealer's License issued by Department of Agriculture Nursery Program.

Pay in Advance Accounts

All new customers will be set up as Pay in Advance accounts. This requires payment in full before or no later than upon receiving shipment.

Credit Terms

Net 30 days, to customers with established credit.

Establishing Credit Terms

Good standing Pay In Advance Accounts after 3 years of business can apply for 30 day credit.

Credit Cards

We accept Visa, Mastercard and Discover.

Service Charge

A service charge of 1.5% per month (18% annual) or \$0.50 minimum is charged on past due accounts.

Prices

Freight is not included in the list prices.

Sales Tax

Under the North Dakota Sales and Use Tax Law, we are required to collect 6% tax on all gross sales of tangible personal property made in North Dakota unless we are presented with a Certificate to the effect that the property purchased is for resale or that the sale is otherwise exempt from sales tax. The law requires us to presume all sales are taxable unless an exempt status is established. Sales to out of state customers are exempt.

Orders

No orders for future delivery can be booked until the previous balance is paid in full.

Minimums

Orders must be minimum \$700. Minimum order amount is waived for purchasers in landscape business.

Shipping

We offer delivery service within 100 mi radius from our nursery. Mileage fee of \$2.50/loaded mile applies. Delivery price can change depending on gas prices.

Orders not reaching minimum purchase of \$700 do not qualify for delivery service.

Customer pick-ups are available free of charge. It is customers' responsibility to be equipped to handle plant material. Enclosed trailer is recommended.

Cancellations

Cancelations made less than 1 day prior to scheduled delivery will be charged a restocking fee.

Restocking Fee

A fee equal to 15% of the value of the order will be invoiced on all cancellations made within 1 day prior to scheduled delivery.

Guarantee

All stock items delivered by us to customers are in saleable conditions, free of disease and pest.

We will not be responsible for any expenses, losses or inconvenience which purchaser may sustain as a result of hail, windstorm, frost, or other weather conditions; as well as we will not be responsible for dehydration, diseases and pest infestations at purchasers care.
